Policy of Bothell Gymnastics Club:

WARNING – DANGER: IT IS IMPOSSIBLE to completely eliminate the danger in gymnastics with padding, foam pits, mats, spotting, coaching or supervision. Although unlikely, a gymnast could be seriously injured while participating in gymnastics.

Gymnastics is inherently dangerous because the gymnast is constantly subject to the force of gravity while maneuvering in the air and on the ground. The moving body may contact other objects that don't move, creating the risk of injury. They gymnast can be injured and the injury can be extremely serious: broken bones or damage to internal organs. These injuries can be extremely painful. Total paralysis and/or death can result from landing improperly on the head, neck or back.

ASSUMPTION OF RISK, WAIVER AND RELEASE OF LIABILITY AGREEMENT
PERMISSION TO TREAT IN AN EMERGENCY

I acknowledge that I am the parent or legal guardian of the child(ren) identified above and voluntarily authorize my child(ren) to participate in gymnastics activities at Bothell Gymnastics Club, Inc. (BGC). **I have read BGC's written warning of dangers inherent in gymnastics and recognize that participating in gymnastics involves risks of serious injury or death, including but not limited to temporary or permanent muscular and skeletal injury and paralysis.**

In consideration of acceptance of my child(ren)'s registration in BGC's gymnastics activities I, and my child(ren) personally assume all risks, whether foreseen or unforeseen, in connection with my child(ren) 's participation in this activity, and **we hereby release, discharge, covenant not to sue BGC and/or it's officers, trustees, employees, agents, and members for any claims, injuries, causes of action, or liability arising from or in connection with my child(ren)'s participation in BGC's gymnastics activities.**

Additionally, we agree to defend, indemnify, and hold harmless BGC, together with it's officers, trustees, employees, agents and members against any and all liability, claims and causes of action arising out of, or in any way connected with my child(ren)'s participation in BGC gymnastics activities. Further, I assume complete responsibility for any property damage and/or personal injury caused by my child(ren) in connection with his/her/their participation in BGC gymnastics.

I have fully and accurately completed the medical information section in my child(ren)'s enrollment application (above) and assert that my child(ren) has/have no physical condition that would prevent or hinder his/her/their participation.

I authorize BGC and it's employees to administer first aid, transport my child to a hospital, initiate medical treatment and hold my child until I can be notified.

I understand this agreement is a contract and shall remain in effect for the duration of my child(ren)'s participation in BGC gymnastics activities. This agreement contains the entire agreement between the parties and supersedes any prior agreement whether oral or written. This Release Agreement shall bind my heirs, personal representatives, assignees, and all members of my family, including minors.
